Taking into consideration of Rule 4 (b) and Rule 33 of Andhra Pradesh State and Subordinate Service Rules, 1996 governing the subject of substantive vacancies and seniority respectively and other relevant Rules, the provisional seniority list of Forest Range Officers as on 01.01.2015 and 01.01.2016 were prepared and communicated vide reference 1<sup>st</sup> cited, to all the Forest Range Officers through respective Conservators Forests, duly inviting objections, if any, within a period of (30) days from the despatch of the said reference i.e on or before 4<sup>th</sup> of April, 2016. The said seniority list was also kept on the departmental web site (means of communication).

Sri Chandraiah, Forest Range Officer on deputation with HMDA, Hyderabad has submitted objections vide representation reference 2<sup>nd</sup> cited and requested to re-examine his seniority taking into consideration and recommendation of the DPC for the panel year 2004-05 as well as criteria of age and date of joining etc. and to re-fix the seniority by placing him at Sl.No.11 of Provisional Seniority list as on 01-01-2016.

Further, Sri M.Barnoba, Forest Range Officer of Nizamabad Circle has submitted objections vide representation reference 3<sup>rd</sup> cited and requested to withdraw the retrospective proposals of Sri N.Venkatesh, Forest Range Officer submitted to the Government in the category of Forest Range Officer and to restore him at roster point no.16 under rule of reservation in the category of Forest Range Officer.

The representations of the above Forest Range Officers have been examined with reference to the connected records and Rules and Court orders/Government Orders/Instructions and their representations have been disposed off by issuing Speaking Orders vide reference 4<sup>th</sup> and 5<sup>th</sup> cited.
