AMENDMENT TO THE TELANGANA STATE FOREST SUBORDINATE SERVICE RULES, 2000.

[G.O.Ms.No.53, Environment, Forests, Science & Technology, (For.II), 26th July, 2022.]

In exercise of the powers conferred by the proviso to Article 309 of Constitution of India and all other powers hereunto enabling, the Governor of Telangana, hereby makes the following amendments to "the Telangana State Forest Subordinate Rules, 2000" issued in G.O.Ms.No. 88, EFS&T (For.IV) Dept., dt:19-07-2000, as amendment subsequently from time to time.

AMENDMENTS

In the said rules:-

(1) In rule (3) for Note (1) (b) and Note (2) (b), the following shall be read as follows:

Rule No	For	Read as
Note (1) (b) of Rule (3)	The vacancies in the category of Forester other than those to be filled by direct recruitment shall be filled by promotion of beat officers to the extent of 50% and by appointment by transfer of Junior Assistant, Junior Stenos Typists, and other equivalent categories in the ministerial service to the extent of 15%. Provided that 50% of the posts of foresters in the notified scheduled areas of the State shall be filled by local members of Scheduled Tribes of the reverent local area notwithstanding anything contained in any other order of rule or law in force.	The vacancies in the category of Forest Section Officer other than those to be filled by direct recruitment shall be filled by promotion of Forest Beat Officers (formerly known as Beat Officer) to the extent of 50% and by appointment by transfer of Junior Assistants, Junior Stenos, Typists, and other equivalent categories in the Ministerial service to the extent of 15%.

Note (2) (b) of Rule (3)	<p>The vacancies in the category of Beat Officers and other than those to be filled by direct recruitment shall be filled by promotion of (i) Assistant Beat Officer including Thanadars and (ii) Plantation watchers, Bungalow Watchers, Boat Sarang in the ratio of 8:1.</p> <p>Provided that 100% of the posts of Beat Officers in the notified scheduled areas of the State shall be filled by members of Scheduled Tribes of the reverent local area notwithstanding anything contained in any other order of rule or law in force.</p>	<p>The vacancies in the category of Forest Beat Officers (formerly known as Beat Officer) and other than those to be filled by direct recruitment shall be filled by Promotion of (i) Assistant Beat Officer including Thanadars and (ii) Plantation watchers, Bungalow Watchers, Boat Sarang in the ratio of 8:1.</p>

(2) In rule (3), the Note (4) shall be deleted.
