ORDER:

The post of Deputy Conservator of Forests is constituted at Category I and the Assistant Conservator of Forests is constituted at Category II, Class-A of Rule 2 of the Andhra Pradesh State Forest Service Rules. As per Rule 3 of the said Rules, the method of appointment to the post of Deputy Conservator of Forests is by promotion from the category of Assistant Conservator of Forests. As per the Indian Forest Service (Recruitment) Rules, 1966, "State Forest Service" means any such service in a State, being a service connected with the Forestry and the Members having Gazetted Status. The year-wise seniority lists of State Forest Service Offices were finalized upto the year 2009.

2. The Principal Chief Conservator of Forests (HoFF), A.P. vide references 2nd and 3rd read above submitted the year wise provisional seniority lists of State Forest Service Officers as on 01.01.2010 to 01.01.2012 & as on 01.01.2013 respectively and requested the Government to approve the same. In the references 4th and 5th read above, Government have approved the same and permitted the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh to communicate the provisional list to all the State Forest Service Officers for making representations, if any. The Principal Chief Conservator of Forests (HoFF), Andhra Pradesh, vide references 6th and 7th read above communicated the year wise provisional seniority lists as on 01.01.2010 to 01.01.2012 and as on 01.01.2013 respectively to all the State Forest Service Officers concerned to put forth objection(s) if any on the year wise provisional seniority lists.

3. In the reference 8th read above, the Principal Chief Conservator of Forests (HoFF), A.P. has stated that objections were received from certain Deputy Conservator of Forests with a request to accord notional promotion, separate seniority lists of Deputy Conservator of Forests and Assistant Conservator of Forests etc., and hence requested the Government to take necessary further action in the matter. The Government after careful examination disposed off the representations vide reference 9th read above, duly according notional promotion and requested the Principal Chief Conservator of Forests (HoFF), A.P. to send the separate provisional seniority lists of Deputy Conservator of Forests and Assistant Conservator of Forests from 1.1.2005 onwards.

4. In the reference 10th read above, the Principal Chief Conservator of Forests (HoFF), A.P. has submitted that the year wise seniority lists of State Forest Service Officers were finalized upto the year 2009 based on the various court orders and the revision of final seniority lists upto 2009 may lead to legal complications and it may lead to review of IFS appointments already accorded upto 2009 based on the final seniority lists upto the year 2009. The Principal Chief Conservator of Forests (HoFF), A.P. has requested the Government to examine the matter and finalize the seniority.

5. In the reference 11th read above, the Principal Chief Conservator of Forests (HoFF), A.P. has been informed that since the provisional seniority lists of State Forest Service officers (Deputy Conservator of Forests and Assistant Conservator of Forests) from 01.01.2010 to 01.01.2013 were already communicated vide references 6th and 7th read above, it shall be finalized by placing all the Category – I (Deputy Conservator of Forests) officers above all the Category – II (Assistant Conservator of Forests) officers duly effecting the notional promotion accorded by the Government vide reference 9th read above and requested the Principal Chief Conservator of Forests (HoFF) A.P. to submit the necessary proposals in consultation with the Principal Chief Conservator of Forests (HoFF), Telangana.

6. Accordingly, the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh consulted the Principal Chief Conservator of Forests (HoFF), Telangana and in the reference 12th read above has submitted the year wise final seniority lists of State Forest Service Officers (Deputy Conservator of Forests and Assistant Conservator of Forests), as on 01.01.2010, 01.01.2011, 01.01.2012 & 01.01.2013 by placing all the Category-I (Deputy Conservator of Forests) officers above all the Category – II (Assistant Conservator of Forests) Officers duly effecting the notional promotion accorded in the reference 9th read above.

7. However, a stand was taken not to finalize the seniority lists for the years 2010, 2011, 2012 & 2013 year wise as proposed by the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh as mentioned in para (6) above and it was decided to publish separate seniority lists of Deputy Conservator of Forests and Assistant Conservator of Forests respectively as on 01.06.2014 i.e. the day prior to appointed day. Accordingly, orders were issued in the references 13th and 14th read above, approving the separate final seniority lists of Deputy Conservator of Forests (Dy.CFs) and Assistant Conservator of Forests (ACFs) respectively as on 01.06.2014 i.e the day prior to Appointed Day.

8. In the references 15th and 16th read above, the Principal Chief Conservator of Forests & (HoFF), Andhra Pradesh has again furnished year wise separate provisional seniority lists of Deputy Conservator of Forests (Dy.CFs) and Assistant Conservator of Forests (ACFs) i.e. State Forest Service Officers from 2005 to 2013 and requested approval of the Government.

9. Meanwhile, in the reference 17th read above, the General Administration Department addressed a letter to the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh informing as below:

“3.the vacancies arose for the Select list years 2010, 2011, 2012, & 2013 for induction of State Forest Officers into Indian Forest Service pertains to Unified Cadre of A.P. The question as to who should process the proposal was addressed by GoI, DOP&T. The DoP&T, Ministry of Personnel, Public Grievances & Pensions, GoI vide their Lr.No.14015/01/2012-AIS(I), dt: 18.12.2014 have informed to the UPSC may go ahead with the Selection process of preparation of pending Select lists upto 2013 of State Service Officers for promotion to All India Services, which may be first prepared for the undivided State of A.P. by both the States in consultation with each other in respect of all the three All India Services, after this the distribution of these officers between the Successor States may be carried out. The issue was taken up with the Govt. of Telangana. The Govt., Telangana has agreed with the procedure in view of the clarification given by GoI in letter, dt: 18.12.2014.

4.the Unified A.P. have forwarded the proposals in respect of IPS for Select list years 2011, 2012 & 2013 for induction of State Police Service Officers into Indian Police Service to UPSC before bifurcation of the State. According to the clarification given by the DoP&T in their Lr. dt:18.12.2014 and keeping in view the provisions made in A.P. Reorganization Act, this State Government with the consent of Govt. of Telangana vide Lr. dt: 03.01.2015 requested the Secy., UPSC for convening the Selection Committee meetings for preparation of pending select lists upto the year 2013 for induction of SCS, Non-SCS, SPS & SFS officers for appointment in to IAS, IPS & IFS cadres of undivided A.P. Accordingly, the Selection Committee meetings convened by the UPSC in respect of induction of State Police Officers into IPS for select years 2011 to 2013. Accordingly, the GoI vide their Notification dt:16.03.2015 have notified appointment of SPS officers in to IPS by promotion for the years 2011 to 2013 which was republished by this State Government in A.P. Gazette vide G.O.Rt.No.902, GA (SC.C) Dept., dt:19.03.2015.

7.the IFS (Appointment By Promotion) Regulations 1966 have been framed in exercise of the powers conferred under the IFS (Recruitment) Rules. The IFS (Recruitment) Rules were made in exercise of the powers conferred under the AIS Act, 1951. Therefore, the Select lists have to be made year wise and the provisions of A.P. Reorganization Act is not against to the same. The clarification given by the GoI vide Lr.dt:18.12.2014 clearly mandates that Select lists up to 2013 should be done by Andhra Pradesh only.”

The General Administration Department have, therefore, requested the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh to submit the proposals for Select lists immediately.”

10. In view of the clarification given by General Administration (SC.C) Department after due consultation with the DoP&T, GoI as stated at para (9) above, it has become necessary to review the orders issued in the G.Os 13th and 14th read above and to prepare year wise seniority lists of State Forest Service (SFS) officers i.e. Deputy Conservators of Forests and Assistant Conservators of Forests as on 01.01.2010, 01.01.2011, 01.01.2012 & 01.01.2013.

11. Further, in the reference 18th read above, the Principal Chief Conservator of Forests (HoFF), A.P. has reported that a meeting was conducted with Principal Chief Conservator of Forests (HoFF), Telangana on 29.04.2017 and decided jointly to withdraw the proposals submitted by the then Principal Chief Conservator of Forests (HoFF), A.P., in references 15th and 16th read above as they were submitted without consulting the Principal Chief Conservator of Forests (HoFF) Telangana and also they are not in tune with the A.P. Forest Service Rules issued in the reference first read above and instructions of the Government vide reference 11th read above. As per the decision taken during the meeting, the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh requested the Government to approve the year wise final seniority lists of State Forest Service Officers (Deputy Conservator of Forests and Assistant Conservator Forests) from 1.1.2010 to 1.1.2013 submitted in the reference 12th read above which was submitted with the concurrence of Principal Chief Conservator of Forests (HoFF), Telangana.

12. The Principal Chief Conservator of Forests (HoFF), A.P. has also informed that, certain Deputy Conservator of Forests filed O.A.No: 1369/2016 before the Hon'ble A.P.A.T., Hyderabad. The Hon'ble A.P.A.T. issued orders dated 20.04.2016 to approve and finalize the year wise final seniority lists of State Forest Service Officers (Deputy Conservator of Forests and Assistant Conservator of Forests) submitted in the reference 12th read above by the Principal Chief Conservator of Forests (HoFF), A.P. in consultation with Principal Chief Conservator of Forests (HoFF), Telangana. The contempt application no. 51/2017 was also filed in O.A.No:1369/2016 and pending before Hon'ble A.P.A.T. for compliance of the orders of the Hon'ble A.P.A.T., dt: 20.04.2016.

13. In view of the clarification given by General Administration (SC.C) Department after due consultation with the DoP&T, GoI at para (9) above, and in view of the facts mentioned in para (12) above, it has become necessary to prepare year wise seniority lists for the years 01.01.2010, 01.01.2011, 01.01.2012 & 01.01.2013, duly superseding the orders issued in the G.Os 13th & 14th read above. Accordingly, Government after careful examination have decided to supersede the orders issued in the G.Os 13th and 14th read above and to approve the year wise final seniority lists of State Forest Service (SFS) Officers as on 01.01.2010, 01.02.2011, 01.01.2012 & 01.01.2013 submitted by the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh, in consultation with the Principal Chief Conservator of Forests (HoFF), Telangana in the reference 12th read above. Accordingly, in supersession of the orders issued in the G.Os 13th and 14th read above, the year wise final seniority of the State Forest Service Officers i.e., Deputy Conservators of Forests and Assistant Conservators of Forests as on 01.01.2010, 01.01.2011, 01.01.2012 and 01.01.2013 in the reference 12th read above is hereby approved and appended as Annexure. I to this order, subject to the outcome of any OAs / W.Ps / W.As / R.Ps / C.As/SLPs etc. if any pending before the Hon'ble A.P. Administrative Tribunal and Hon'ble Courts.

14. The objections received from the individual SFS Officers i.e., Dy.CFs and ACFs are also hereby disposed off as appended in Annexure – II and Annexure– III respectively.
